AGREEMENT TERMS

1. Legal Compliance and Responsibility

- a. The Organizer acknowledges awareness of Legislative Decree No. 40 dated 28 February 2021 and agrees to prepare the race and training slope in full compliance with applicable laws.
- b. The Organizer assumes full and exclusive responsibility and liability for the conduct of all training sessions or events on the reserved slope.

2. Safety Obligations

- a. The Organizer commits to ensuring the safety of all racers, spectators, and skiers during all activities.
- b. Prior to each use, the Organizer shall inspect the slope and all safety equipment to confirm their suitability for racing or training purposes.

3. Reporting and Suspension of Use

- a. If any defects or hazards are identified that could jeopardize safety or activity integrity, the Organizer shall immediately notify the Company in writing.
- b. The Organizer agrees to suspend the use of the slope until the issues have been resolved and the slope is deemed safe.

4. Ongoing Monitoring and Access Control

- a. During the reserved period, the Organizer shall regularly monitor the condition of the slope and safety installations.
- b. The Organizer shall prevent unauthorized access to the restricted slope by erecting and maintaining all required signage and, if necessary, supplementing it with additional measures.

5. General Safety Measures

The Organizer shall, on their own initiative, implement all necessary safety measures to minimize risks as much as possible for racers, skiers, and any other persons involved.

6. Authorization and Insurance

The Organizer declares that they are authorized to organize the event and hold a valid liability insurance policy covering all risks related to the event in question, as well as accident insurance covering the athletes involved.

7. Reservation of the Course

The reservation of the course is confirmed by signing this Agreement prior to commencing any training or use of the course.



8. Cancellation of Reservations

- Reservations may be canceled up to three days before a training session and at least one week before an event or race.
- In case of no show or cancellation after established deadlines, a cancellation fee of € 50,00 shall apply and must be paid by the Organizer (except cases of cancellation due to adverse weather conditions)

9. Pre-Use Responsibilities

Prior to beginning training or using the course, the person appointed by the Organizer as responsible must:

- Personally inspect the course and eliminate any hazards or ensure they are removed before starting any competitive activity.
- Place a "Course Closed" sign at the entrance of the course and, if unauthorized persons attempt to access the course, instruct them to leave and monitor to ensure compliance.

10. End of Reserved Period Responsibilities

At the end of the reserved time, the Organizer must:

- Change the signage at the course entrance to "Course Open."
- Remove all equipment from the course before the reserved time expires.
- Report any issues or damaged materials to the Company that occurred during training.

11. Company's Rights

The Company reserves the right to cancel any booked training sessions in case of assignment of races or other events deemed necessary to hold during the winter season.

The Organizer will be informed as soon as possible, and the event will be included in the official calendar.

This Agreement is made in good faith and shall remain effective according to the terms herein.
